**When and Where:**

Southern Illinois' Largest Indoor Garage Sale will be held Saturday, March 27, 2010 from 7:00am to 2:00pm at The Williamson County Pavilion, 1602 Sioux Drive, (behind the mall) in Marion, IL. Tables will be provided for all garage sale vendors. The admission for shoppers is FREE and concessions will be sold by the Williamson County Pavilion. The Williamson County Pavilion will promote Southern Illinois' Largest Indoor Garage Sale through radio and print advertisements.

**Unsold Merchandise:** Unsold merchandise must be taken with you at the conclusion of the event on Saturday, March 27. Garage sale vendors are responsible for disposing unsold items. No items may be left at the Williamson County Pavilion. If items are left you will incur a \$25.00 removal fee by the Williamson County Pavilion.

**Setting Up:** The Williamson County Pavilion will be open Friday, March 26 from 5:00pm to 9:00pm for set up. All vendors must set-up that evening. The Williamson County Pavilion will provide security overnight on Friday, March 26 until the following morning. Vendors will be able to enter the building on Saturday at 6:30am and the sale will begin at 7:00am. All items must be removed from the venue by 3:00pm on March 27<sup>th</sup>. **DEADLINE FOR**

**REGISTRATION:** all vendors must have their payment to The Williamson County Pavilion, 1602 Sioux Drive, Marion, IL 62959 with their completed registration form and liability waiver by Friday, March 19, 2010. **DROP OFF TIMES:** Monday- Friday 8:00 am to 4:30, closed 12:00 pm to 12:30 pm for lunch. Please make checks payable to: The Williamson County Pavilion. Tables will be designated in order of registration, no changing tables. Space is limited on first registration basis. In the event of a cancellation by the The Williamson County Pavilion, all garage sale vendors will be given a full refund. If you cancel your table reservation on or before Friday, March 27, 2010 you may receive a full refund. There will be no refunds for garage sale vendors if they cancel after Friday March 27, 2010 or for vendors who do not show up day of sale.

**Items that may NOT be sold:** Garage sale vendors will not be permitted to sell or bring in the following items: any food or drink items, firearms, knives, weapons, paint ball guns, bb guns, cross bows, fireworks, popping caps, explosives, live animals, pirated media, adult entertainment items, illegal items, counterfeit or stolen goods, large appliances, or motorized lawn equipment.

**General notes**

\*No animals, other than sight-seeing animals will be permitted into the building.

\*No playing/singing of music.

\*There will be no refunds for merchandise.

\*Have plenty of coins and small bills on hand. The Williamson County Pavilion will not provide change.

\*Parking will be on a first come first serve basis.

\* No vehicles will be allowed inside the Williamson County Pavilion.
